In exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), the Government of Kerala hereby make the following rules further to amend the Kerala Co-operative Societies Rules, 1969, the same having been previously published under Notification No. B1/179/2021/Co-op dated 17th March, 2022 in the Kerala Gazette Extraordinary No. 882 dated 17th March, 2022, as required under sub-section (1) of section 109 of the said Act namely:-



RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Co-operative Societies (Fourth Amendment) Rules, 2022.

(2) They shall come into force at once.

2. *Amendment of the Rules* .- In the Kerala Co-operative Societies Rules, 1969, -

(1) Clause (iv) of sub-rule (2) of rule 185 shall be omitted;

(2) After sub-rule (2) of rule 185 the following sub-rule shall be inserted, namely :-

“(2a) substantive vacancies in the post of Assistant Secretary/Manager and equivalent posts in Primary Co-operative Societies and Urban Banks having a deposit up to twenty crores shall be filled up by promotion and direct recruitment in the ratio of 3:1.”

“(2b) substantive vacancies in the post of Assistant Secretary/Manager and equivalent posts in Primary Co-operative Societies and Urban Banks having a deposit of twenty crores up to hundred crores shall be filled up by promotion and direct recruitment in the ratio of 2:1.”

“(2c) substantive vacancies in the post of Assistant Secretary/Manager and equivalent posts in Primary Co-operative Societies and Urban Banks having a deposit with more than hundred crores shall be filled up by promotion and direct recruitment in the ratio of 1:1.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The method of appointment of Assistant Secretary/Manager and equivalent posts in the Primary Co-operative Societies and Urban Banks are being done by direct recruitment and by promotion in the ratio mentioned therein. The ratio that mentioned therein require certain clarifications which causes ceratin court cases also. In order to comply the direction of the Hon'ble High Court in WP(C)No.17769/2019, the Government have decided to make suitable amendments in the said rules between the direct recruitment and by promotion in the ratio prescribed therein on the basis of the amount of deposits in the respective societies concerned.

This notification is intended to achieve the above object.
