In exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Rules, 1969(21 of 1969), the Government of Kerala hereby make the following rules further to amend the Kerala Co-operative Societies Rules, 1969, the same having been previously published under Notification No.B1/73/2021/Co-op dated



22<sup>nd</sup> April, 2021 in the Kerala Gazette Extra Ordinary No. 1520 dated 30<sup>th</sup> April, 2021, as required by sub-section 109 of the said Act namely:-

## RULES

1) *Short title and commencement.*- (1) These rules may be called the Kerala Co-operative Societies (Second Amendment) Rules, 2022.

(2) They shall come into force at once.

*2) Amendment of the Rules.*- In the Kerala Co-operative Societies Rules, 1969, in item (viii) of the sub-rule (4) of rule 182, the following sentence shall be added at the end, namely:-

"All vacancies arising during the existence of the said rank list shall be reported to the Examination Board and such vacancies shall be filled by the committee from the list of candidates so advised by the Examination Board."

# **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

In item No.viii of sub-rule (4) of rule 182 of the Kerala Co-operative Societies Rules, 1969, all appointments to the vacancies shall be made by the committee from the select list published.

In order to clarify the rule and also by considering the application submitted by the Co-operative Service Examination Board it is necessary to amend the rule. The draft rules were previously published as required under sub-section (1) of section 109 of the



Kerala Co-operative Societies Act, 1969 (Act 21 of 1969) as per Notification No. B1/73/2021/Co-op dated 22<sup>nd</sup> April, 2021 published in the Kerala Gazette Extraordinary No. 1520 dated 30<sup>th</sup> April, 2021, inviting suggestions or objections, if any, in respect of the said draft rules. Government considered the matter in detail and are decided to amend the item No. viii of sub-rule (4) of rule 182 of the Kerala Co-operative Rules, 1969.

This notification is intended to achieve the above object.
