In exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the Government of Kerala hereby make the following rules further to amend the Kerala Co-operative Societies Rules, 1969 the same having been previously published under Notification No. Co-op-B1/312/2019/Co-op dated 25th May, 2020 in the Kerala Gazette Extraordinary No 1321 dated 1st June, 2020 as required by sub-section (1) of

section 109 of the said Act, namely:-

RULES

- (i) *Short title and commencement.*- (1) These rules may be called the Kerala Co-operative Societies (5th Amendment) Rules, 2020.
(2) They shall come into force at once.
- (ii) *Amendment of the Rules.*- In the Kerala Co-operative Societies Rules, 1969.-
in sub-rule (4) of rule 182.-
(a) in second proviso to sub clause (iii) for the words “ ten times” the words “fifteen times ” shall be substituted;
(b) for clause (vii), the following clause shall be substituted, namely:

“On the basis of the consolidated list of candidates the Examination Board shall prepare the rank list of candidates and publish the same in the notice board of the Examination Board within a period of twenty days from the date of preparation of such consolidated mark list. The Examination Board shall send one copy of the rank list so published to the societies concerned. Examination Board will advise such list of candidates based on the vacancies reported by the respective societies. The list shall be valid for a period of two years from the date of publication of the same by the Examination Board” .

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 80B of Kerala Co-operative Societies Act, 1969 the Government shall, by notification in the Gazette constitute a Co-operative Service Examination Board for the conduct of written examination for all



direct recruitment to posts of and above the category of Junior Clerks in the Primary Agricultural Credit Societies, Primary Credit Societies, Urban Co-operative Banks and Primary Co-operative Agricultural and Rural Development Banks in the State. The Co-operative Service Examination Board has requested the Government to amend the sub clause (iii),(vii) of sub rule (4) of rule 182 of the Kerala Co-operative Societies Rules, 1969 so as to increase the number of candidates to be called for interview and to advice such candidates. Government considered the matter in detail and are pleased to amend the sub clause (iii),(vii) of sub-rule (4) of rule 182 of the Kerala Co-operative Societies Rules, 1969.

The Draft Rules were previously published as required under sub-section (1) of section 109 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969) as per Notification No.Co-op/B1/312/2019/Co-Op dated 25 May, 2020 published in the Kerala Gazette Extraordinary No.1321 dated 1st June, 2020, inviting suggestions or objections, if any, in respect of the said Draft Rules. Government have received certain suggestions and objections and considered the same and have decided to make necessary modification in the Draft Rules, before finalising the same.
