In exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), the Government of Kerala hereby make the following rules, further to amend the Kerala Co-operative Societies Rules, 1969, the same having been previously published under Notification No.Co-Op-B1/34/2021/Co-op. dated 9<sup>th</sup> July, 2021 in the Kerala Gazette Extraordinary No.2424 dated 17<sup>th</sup> August, 2021, as required by sub-section (1) of section 109 of the said Act, namely:-



## **RULES**

1. *Short title and commencement.*- (1) These rules may be called the Kerala Cooperative Societies (Fifth Amendment) Rules, 2022.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Co-operative Societies Rules, 1969, after item No.(iv) of sub-rule (1) of rule 186, the following item and note shall be inserted, namely:-

Note:- The recruitment to the post of appraiser in the Primary Urban Co-operative Banks shall be made through Co-operative Service Examination Board.”

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-rule (1) of rule 186 of the Kerala Co-operative Societies Rules, 1969, specifies the qualifications for the appointment of employees in a Co-operative Society. In the pay revision order the scale of pay of Appraisers in Primary Urban Banks were equivalent to that of Junior clerks. Hence it became necessary to fix the qualification for the post of Appraiser. The draft rules were previously published as required under sub-section (1) of section 109 of the



Kerala Co-Operative Societies Act, 1969 (Act 21 of 1969) as per Notification No. Co-op-B1/34/2021-Co-op. dated 9<sup>th</sup> July, 2021 in the Kerala Gazette Extraordinary No.2424 dated 17<sup>th</sup> August, 2021 inviting suggestions or objections, if any, in respect of the said draft rules. The Government have considered the matter in detail and have decided to fix the qualification of appraisers and entrust the recruitment in the Primary Urban Co-operative Banks to the Co-operative Service Examination Board.

This notification is intended to achieve the above object.
